Fall Public Speaking Contest

Purpose – To encourage young leaders to be more aware of the forest and wood processing industry and to advocate for sustainable management and sound stewardship of Missouri’s forests to benefit current and future generations.

Eligibility – The Missouri Forest Products Association FFA Public Speaking Contest will be open to FFA students who are enrolled in vocational agriculture courses during the current calendar year.

Dates of Competition – Area and District competition dates will be determined by FFA. Each district will be allowed to send one contestant to the state competition. The state competition will be held in conjunction with the MFPA Winter Meeting held in Jefferson City at the Courtyard Marriot. The date for the competition will be January 14, 2025.

Theme – Loggers are a very important part of the forest products industry and face many dangers in their day to day duties. What are ways to promote logger safety in the woods so they can carry out their jobs safely, efficiently, and positively promote themselves to forest landowners?

Time Limit - Each speech shall be no less than six minutes and no more than eight minutes in length. Each contestant will be allowed five

minutes additional time in which he or she will be asked questions pertaining to the theme.

Speech Preparation - Each contestant's manuscript will be the result of their own efforts. The speech should be prepared on double spaced typewritten pages of white bond paper, 8.5 x 11 inches.

Bibliography - A complete and accurate bibliography must be included. All contestants in the Missouri Forest Products Association FFA Public Speaking Contest should give credit to others where any direct quotes or phrases are used in the manuscript.

1. Four double spaced typed copies of the speech on 8.5" x 11" white paper.
2. A signed statement that the contestant's speech is the result of their own work.
3. Bibliography.

The first place winner will present their speech to the attendees at the MFPA Winter Meeting Banquet on January 14, 2025.
